

How to Use the Schedule and Map

- Choose the direction you wish to travel.
- Time points are listed from the beginning of the route (on the top) to the end of the route (on the bottom).
- If your stop is between two designated time points, you can flag the shuttle at a safe corner.
- Connections to NJ TRANSIT bus routes are indicated and are listed on the route.

Operation Regulations

- The 8A Shuttle runs Monday through Saturday except on the holidays noted in the Holiday Schedule.
- The suggested fare is \$1.00 each way for the general public, \$.50 for senior citizens and people with disabilities. Exact change is required.
- Passengers boarding and disembarking beyond Wal-mart will be charged \$1.50/.75 for seniors and people with disabilities.
- The shuttle driver WILL NOT make change.
- Timetable can be obtained in alternate formats upon request.

Bus Stops and Route Deviation

- Passengers can request a route deviation within two blocks of the route which needs to be requested by 3:00 p.m. on the day prior to service by calling: 1-800-221-3520.
