

AN ORDINANCE TO AMEND AND SUPPLEMENT THE REVISED GENERAL ORDINANCES OF THE CITY OF NEW BRUNSWICK CHAPTER 10, "VEHICLES AND TRAFFIC"

BE IT ORDAINED by the New Brunswick City Council, as follows:

SECTION I

Section 10.20.010, Schedule 39, "Parking Zones for Handicapped Persons" is hereby amended to **DELETE** the following:

| <u>STREET</u> | <u>SIDE</u> | <u>LOCATION</u> |
|---|-------------|---|
| 265 Delavan Street (Placard No. P332375) | Northeast | Beginning at a point 206 feet from the northerly curb line of Joyce Kilmer Avenue and extending to a point 12 feet northwest thereof. |
| 102 Comstock Street (Placard No. P1543956) | Northwest | Beginning at a point 264 feet from the northeasterly curb line of Throop Avenue and extending to a point 23 feet southeast thereof. |

SECTION II

Section 10.20.010, Schedule 39, "Parking Zones for Handicapped Persons" is hereby amended to **ADD** the following:

| <u>STREET</u> | <u>SIDE</u> | <u>LOCATION</u> |
|---|-------------|---|
| 265 Delavan Street (Placard No. P1779905) | Northeast | Beginning at a point 206 feet from the northerly curb line of Joyce Kilmer Avenue and extending to a point 12 feet northwest thereof. |
| 102 Comstock Street (Placard No. P2037665) | Northwest | Beginning at a point 264 feet from the northeasterly curb line of Throop Avenue and extending to a point 23 feet southeast thereof. |

SECTION III

SEVERABILITY:

If any subsection, paragraph or provision of this Ordinance is declared to be invalid by a court of competent jurisdiction, such finding shall not affect the remaining provisions hereof which shall remain in full force and effect.

SECTION IV

REPEALER:

All ordinances inconsistent with the provisions of this Ordinance are repealed to the extent of such inconsistency.

SECTION V

EFFECTIVE DATE:

This Ordinance shall become effective twenty (20) days following final adoption and publication as required by law.




