

AN ORDINANCE TO AMEND AND SUPPLEMENT THE REVISED GENERAL ORDINANCES OF THE CITY OF NEW BRUNSWICK TITLE 10, "VEHICLES AND TRAFFIC"

BE IT ORDAINED by the New Brunswick City Council, as follows:

SECTION I

Title 10, Chapter 10.20, Section 10.20.010 - Schedule 39, "Parking Zones for Handicapped Persons" is hereby amended to **ADD** the following:

<u>STREET</u>	<u>SIDE</u>	<u>LOCATION</u>
4 Chester Circle, Apt. 1B Placard No. P1943082	Southwest	Beginning at a point 66 feet from the easterly curbline of Chester Circle and extending to a point 23 feet southeast thereof.
17 North Ward Street, Apt. 2 Placard No. P1931685	North	Beginning at a point 177 feet from the southeasterly curbline of Commercial Avenue and extending to a point 23 feet west thereof.
39 Wright Place Placard No. P2003818	South	One 23-foot space located alongside Apartment Building No. 19.

SECTION II

SEVERABILITY:

If any subsection, paragraph or provision of this Ordinance is declared to be invalid by a court of competent jurisdiction, such finding shall not affect the remaining provisions hereof which shall remain in full force and effect.

SECTION III

REPEALER:

All ordinances inconsistent with the provisions of this Ordinance are repealed to the extent of such inconsistency.

SECTION IV

EFFECTIVE DATE:

This Ordinance shall become effective twenty (20) days following final adoption and publication as required by law.
