

AN ORDINANCE TO AMEND AND SUPPLEMENT THE REVISED GENERAL ORDINANCES OF THE CITY OF NEW BRUNSWICK, TITLE 12, STREETS, SIDEWALKS AND PUBLIC PLACES, CHAPTER 12.20 "ABANDONED, WRECKED AND REPAIR OF VEHICLES ON STREETS"

BE IT ORDAINED by the New Brunswick City Council, as follows:

SECTION I

Title 12, Chapter 12.20, Section 12.20.010, "**Definitions**" - **Vehicles** is hereby amended as follows:

"Vehicle" means a machine propelled by power, other than human power, designed to travel along the ground by use of wheels, treads, runner or slides, and transport persons or property or pull machinery, and shall include, without limitation, automobile, truck, trailer, motorized scooter, electric scooter, electric bicycle, motorcycle, tractor, buggy and wagon.

SECTION II

Title 12, Chapter 12.20, Section 12.20.030, "**Leaving of wrecked, nonoperating vehicles, or repair of vehicles on street—Prohibited**" is hereby amended as follows:

- A. No person leaves any partially dismantled, nonoperating, immobile, wrecked or junked vehicle on any public right-of-way, street or highway within the city.

SECTION III

SEVERABILITY:

If any section, paragraph or provision of this Ordinance is declared to be invalid by a court of competent jurisdiction, such finding shall not affect the remaining provisions hereof which shall remain in full force and effect.

SECTION IV

REPEALER:

All ordinances inconsistent with the provisions of this Ordinance are repealed to the extent of such inconsistency.

SECTION V

EFFECTIVE DATE:

This Ordinance shall become effective 20 days following final adoption and publication as required by law.




