

AN ORDINANCE TO AMEND AND SUPPLEMENT THE REVISED GENERAL ORDINANCES OF THE CITY OF NEW BRUNSWICK, TITLE 13, PUBLIC SERVICES, CHAPTER 13.04, "WATER SERVICE SYSTEM"

BE IT ORDAINED, by the City Council of the City of New Brunswick as follows:

SECTION I

Chapter 13.04, "Water Service System", is amended to **ADD** the following section:

Section 13.04.015 – Water Connections

Any building which requires or uses water, now or hereafter erected on any lot abutting a street in which a water line is now or hereafter constructed, shall be connected with such water line as follows:

1. Existing buildings: within ninety (90) days after adoption of this section.
2. New buildings: prior to occupancy thereof.
3. Building on a street in which a water line is hereafter constructed; within ninety (90) days after completion of the construction of such water line.

SECTION II

SEVERABILITY:

If any subsection, paragraph or provision of this Ordinance is declared to be invalid by a court of competent jurisdiction, such finding shall not affect the remaining provisions hereof which shall remain in full force and effect.

SECTION III

REPEALER:


All Ordinances inconsistent with the provisions of this Ordinance are repealed to the extent of such inconsistency.




