

AN ORDINANCE TO AMEND AND SUPPLEMENT THE REVISED GENERAL ORDINANCES OF THE CITY OF NEW BRUNSWICK, TITLE 13, PUBLIC SERVICES, CHAPTER 13.08, "SEWER SERVICE SYSTEM"

BE IT ORDAINED, by the New Brunswick City Council as follows:

SECTION I

Title 13, Chapter 13.08, Sewer Service System, shall be amended to read as follows:

SECTION II

Section 13.08.340, Schedule A – Schedule of Charges. The charges of all **sewer** services furnished by the City of New Brunswick shall be in accordance with the following rates:

- b. Industrial Rates.
- (1) Flow – per 1,000 gallons per **month**.

YEAR	AMOUNT
2019	\$7,111.91
2020	\$7,467.51

A 3.95% surcharge will be assessed on all industrial flow rates per month.

- (2) BOD – per ton per **month**.

YEAR	AMOUNT
2019	\$1,010.07
2020	\$1,060.57

A 3.95% surcharge will be assessed on all industrial BOD rates per month.

- (3) Suspended Solids – per ton per **month**.

YEAR	AMOUNT
2019	\$399.80
2020	\$419.79

A 3.95% surcharge will be assessed on all industrial Suspended Solids rates per month.

SECTION III

SEVERABILITY:

If any subsection, paragraph or provision of this Ordinance is declared to be invalid by a court of competent jurisdiction, such finding shall not affect the remaining provisions hereof which shall remain in full force and effect.

SECTION IV

REPEALER:


All Ordinances inconsistent with the provisions of this Ordinance are repealed to the extent of such inconsistency.


