

AN ORDINANCE TO AMEND AND SUPPLEMENT THE REVISED GENERAL ORDINANCES OF THE CITY OF NEW BRUNSWICK TITLE 10, "VEHICLES AND TRAFFIC"

BE IT ORDAINED by the New Brunswick City Council, as follows:

SECTION I

Title 10, Chapter 10.20, Section 10.20.010 - Schedule 39, "Parking Zones for Handicapped Persons" is hereby amended to **ADD** the following:

<u>STREET</u>	<u>SIDE</u>	<u>LOCATION</u>
275 Comstock Street (Placard # P2266872)	North	Beginning at a point 414 feet from the northwesterly curbline of Livingston Avenue and extending to a point 23 feet northwest thereof.
61 Throop Avenue (Placard # P2333969)	West	Beginning at a point 106 feet from the southwesterly curbline of Throop Avenue and extending to a point 23 feet west thereof.
313 Suydam Street (Placard # P1310027)	Northeast	Beginning at a point 130 feet of the easterly curbline of Railroad Avenue and extending to a point 23 feet east thereof.

SECTION II

SEVERABILITY:

If any subsection, paragraph or provision of this Ordinance is declared to be invalid by a court of competent jurisdiction, such finding shall not affect the remaining provisions hereof which shall remain in full force and effect.

SECTION III

REPEALER:


All ordinances inconsistent with the provisions of this Ordinance are repealed to the extent of such inconsistency.

SECTION IV

EFFECTIVE DATE:

This Ordinance shall become effective twenty (20) days following final adoption and publication as required by law.


